For the collection, storage, processing and transmission of member data

When a member joins, the following data is collected:

PROCESSING INFORMATION

The information collected is stored in the cooperative's own DSGVO-compliant EDP system. Each member is assigned a membership number. The personal data is protected from third parties by appropriate technical and organisational measures.

Other information and data on the member are only processed internally by the association if they are useful for the promotion of the purpose of the cooperative and there are no indications that the person concerned has an interest worthy of protection which opposes the processing.

o You will be invited to meetings by the cooperative via your address and, if applicable, e-mail address (Art. 6 Para. 1 c DS-GVO in conjunction with § 46 Para. 1 Sentence 1 GenG in conjunction with § 6 No. 4 GenG), and will also be informed about developments in the cooperative within the scope of membership (Art. 6 Para. 1 b DS-GVO in conjunction with § 1 Para. 1 GenG in conjunction with the Articles of Association).

DISTRIBUTION

Personal data will not be passed on to third parties unless consent is given for this in individual cases. However, we are legally obliged in some cases to grant third parties access to personal data. This concerns, for example, the statutory auditing association or authorised authorities.

The data will be stored or deleted in accordance with the legal deadlines

When a member leaves the cooperative, the company, address, name, telephone number, e-mail address are kept by the Executive Board for up to ten years from the date of departure in accordance with the provisions of tax law. They will be blocked and archived.

You have the right to obtain information from the data controller about the personal data concerned and to request authorisation or deletion or restriction of processing (unless this is prevented by a statutory provision). In addition, you have the right to lodge a complaint with a supervisory authority (Landesbeauftrage für Datenschutz).

In the context of the declaration of membership, the member confirms that he/she has taken note of this data protection declaration.
